- 6. Expanding the Department's canine unit with three new police canines.

Detective William S. Holihen. Born in Providence on July 22, 1935, he was the son of the late Joseph and Gertrude (Faust) Holihen After proudly serving in the U.S. Marine Corps for three years, Bill was appointed to the Cranston Police Department on December 3, 1956 and retired on January 6, 1987 while achieving the rank of Detective. When he was not solving cases for the PD, he loved golfing, travelling with his family, and watching a good movie on his TV. Detective Holihen was survived by his wife Elizabeth A. Holihen; son William R. Holihen and his wife Joanne; daughter Gina M. Holihen; granddaughter Taylor Holihen; and two brothers Joseph and John Holihen. He also now has a grandson William S. Holihen II with his namesake. Bill passed away on December 27, 1995. Keep hitting them straight.

**Detective William F. Quinn.** Born in Providence on April 6, 1942, he was the son of the late Robert and Ellen (Mahoney) Quinn. After serving in the U.S. Navy for two years, Bill joined the Department in April of 1966 and retired in 1996 after proudly serving for over 30 years. During his career, Billy served in the Patrol, Traffic, and Detective Divisions. He also served with the U.S. Marshall Service in Providence and the RI State Police Violent Fugitive Task Force for 11 years before retiring. Detective Quinn was survived by his loving wife of over 44 years Janice (Fitzgerald) Quinn and his children David W., Brian J. and Suzy Quinn. Known for his dry wit, Bill loved playing golf, watching hockey games and an occasional cold one. Bill passed away on March 21, 2010. Go BU Hockey Terriers!!


