## A Blast From The Past - "ONE MAN'S IDEA"

The following is an excerpt from a previous article from the 10-4 which was published on February, 2004.

"In May of 1994 just before he planned to retire from the Cranston Police Department, Rico Maccarone had an idea. Rico sent out a letter to all retired members on May 23, 1994 seeking their input and asking them to join a social organization, where the members would meet periodically.

The first meeting was held at the Providence/Cranston Elks Home at 1895 Plainfield Pike, Johnston, RI. Thirty-one retirees showed up and paid their dues. Rico was elected President, Joe Pelosi, Vice President, Dan Cipalone, Treasurer and Joseph Cicione, Secretary. From this humbling beginning of 33 retirees out of a possible 109, the association has grown to 125 out of 142.

On February 15, 2001 the Association was charted as a Non-Profit Corporation by the State of RI under the title of Cranston Police Department Retirees Association..

The specific purpose of

the association was to bring all retired members of the CPD under one organization and to be committed to helping in social and economic benefits for retirees and their families. What was one man's ideas has became a necessity, after what has transpired over the past year concerning our pensions."

This issue of the 10-4 is dedicated to Rico Maccarone, Joseph Cicione and all previous CPDRA officers and board members who have given so much for what we have today.

As of early August, our CPDRA lawyer has informed us that he is still working with the city's lawyers to finalize the proposal that will affect retired CPD officers (this will not affect widows receiving a COLA if approved by the majority of

retirees and widows).

Tentatively he is looking at a possible October 2013 hearing date in Superior Court where both sides, for and against, will be heard.

In the event that the judge finds this proposal fair and equitable for all

parties, it is our belief that the city will be ordered to notify all retirees and widows on the option of either accepting or refusing it through mail.

During each issue of the 10-4 Newsletter, we will take the opportunity to honor those CPD members who are no longer with us and who continually placed their lives on the line to serve and protect the citizens of Cranston, R.I.

<u>Detective Enrico (Rico) C. Maccarone, Badge#70.</u> Born in Providence to Gabriele and Mary Maccarone, Rico joined the Cranston Police Department on October 2, 1967 and retired on July 29, 1994 as a Detective in the department. As our first CPDRA President and founding member, Rico was a visionary who had an idea and followed it through for benefitting CPD retirees and their family. Never one to stand still, Rico loved travelling, golf, skiing and softball. He was also an avid Yankees fan (we still loved him). Rico passed away on June 10, 2008. **Car 305, this first edition, and all future 10-4 Newsletters, are dedicated to you.** 

Major Edward R. Manocchia, Badge# 99. Born in Providence on May 2, 1933, Ed was sworn in as a patrolman on April 28, 1958 and retired as a Major on September 1, 1987. Besides being a co-founder of I.B.P.O. 301, he was a magna cum laude graduate of PC and Roger Williams College and one heck of a polygraph operator for the department. Although having a sometimes gruff exterior, Ed had a heart of gold and was a masterful joke teller. He passed away on May 8, 2010.

**Lieutenant Robert J. Carroll, Badge# 137.** Born in Providence, Bob graduated Cranston High School East in 1960. He began his career with the Cranston Police Department on September 8, 1965 and retired on September 23, 1991 with the rank of Lieutenant. Besides being a past president of the I.B.P.O. #301, he was very active in our CPDRA association and with other activities within the city of Cranston. As a graduate of Bryant College, Bob took the time to teach Youth and Law at Cranston High East so students could become better citizens. He passed away on January 15, 2008

Officer Michael Gunson. Born in Rochester, NY on February 17, 1958 to the parents of John and Donna Gunson. Mike was sworn in as a patrolman to the Cranston Police Department on September 5th, 1987. Prior to becoming a police officer, Mike proudly served with the U.S. Marine Corps where he trained with the Navy Seals and received numerous decorations. Besides weight lifting and scuba diving, Mike loved running and was a participant in two RI triathlons. He was also a key member in starting the department's scuba team and was a member of the CPD SWAT Team. He is survived by his wife Maria Gunson, his son Michael, both parents, brother Dennis and sisters Kathy, Mary, and Jennifer. Officer Gunson passed away on October 9th, 1993.

In this month's issue of the 10-4, the officer being recognized was hired on August 12th, 1975 and retired on October 9th, 1995 with the rank of Captain.

He has a BS in Law Enforcement and a Masters Degree in Criminal Justice from Salve Regina University.
