As we begin the new year, our finances have never been better. With donations from the Cranston FOP, Ms. Dolores Carroll, Mrs. Nancy Hackett, Mrs. William Holihan and collecting dues, our checking account is now at \$9,469.87. Coupled with our \$1,795.75 in savings, we now have a total of \$11,265.64 in our accounts. Thank you all for your continued support.

I have completed the CPD Memorial Brick Form

and will soon be sending it to the Colonel for distribution to all current CPD officers and civilians wishing to purchase a brick.

AN USUAL CRANSTON CHIEF'S BADGE

Recently an acquaintance of mine who is a police officer in Massachusetts, and shares an interest in police history, sent me two photos of a Cranston Chief's badge from his collection that once belonged to James G. Miller, who served as Cranston's Chief of Police from 1929 to 1941.

Chief Miller was one of the first original ten full-time patrolman appointed to the department in 1910 when the city formally established the police department under city ordinance, although he'd served as a police constable since the 1890's. In 1912 he was promoted to Inspector, and served as the department's first detective.

What makes the badge so interesting is that besides the chief's name being engraved on the back, it also has a Masonic emblem attached, which indicates it was likely a "presentation" badge given to Chief Miller by a local Masonic lodge. (I was once told that many Cranston officers in the early 1900s were also Masons.)

Another reason to believe the badge wasn't issued by the department is that its style is inconsistent with the type of badges issued to Cranston officers in that era. The above photo of Chief Miller is a case in point. It shows him wearing a modified patrolman's badge with an eagle top—a style that was still worn by Chief Fouche court in the 1960s. Of course, being the guy in charge, Chief Miller could have worn any badge he chose, and perhaps wore this one on his shirt under his tunic. I've offered to trade for or buy the badge, but so far no luck. This piece of CPD history was written by our managing editor, retired CPD Sgt. James Ignasher.

During each issue of the 10-4 Newsletter, we will take this opportunity to honor those CPD members who are no longer with us and who continually placed their lives on the line to serve and protect the citizens of Cranston, R.I.

Detective Nicholas A. Gualtieri. Born in Providence, he was the son of the late Giuseppe and Angelina (Rattenni) Gualtieri. Nichols was a veteran, and served as an Airman in the Korean War. He attended weekly Mass at St. Bartholomew's Church where he served as a usher. Detective Gualtieri served honorably with the Cranston Police Department from December 3, 1956 to January 4, 1987. He is survived by his former wife Dolores (Cedrone) Gibbs and his three daughters, Diane, Carol and Maureen Mitchell.

Detective Joseph V. Fortuna. Born in Providence, he was the son of the late Harry and Elizabeth Fortuna. A long time resident of Cranston, Detective Fortuna honorably served with the Cranston Police Department with 35 years of service. After retiring, Joe served another 15 years for the city in the position of truant officer. He is survived by his wife Jeanette (DiLibero) Fortuna and son Edward Fortuna of Cranston.

Officer Leonard F. (Lenny) D'Errico Born in Providence, he was a son of the late Edward J. and Jennie (Calitri) D'Errico. After displaying his football skills while attending and graduating Cranston High School East, he later joined the Cranston Police Department. After honorably serving on the department, Lenny went on to work for the Cranston Public Schools Athletic Department where you could see him at numerous events. Officer D'Errico passed away on December 24, 2018. He is survived by loving children Dawn Piechocki and Derek D'Errico, and his sister Sandra Garganese.


